5. Turn left onto the ramp to I-495 South
6. Keep right at the fork, follow signs for Interstate 495 S/Cape Cod and merge onto I-495 South
7. Merge onto I-495 South
8. Take exit 23A to merge onto MA-9 E/ State Route 9 E Toward Framingham
9. Turn right onto Mercer Road
10. Turn right onto Strathmore Road

**Destination will be on the right.**

**DIRECTIONS TO SHOW**

**The Royal Plaza Trade Center** is located 0.5 miles west of the Intersection of Interstate 495 and Route 20 (Boston Post Road W) in Marlborough, MA.

**On Interstate 495 in Massachusetts, take Exit 24B.**

**From the North:** Follow the ramp to the stop sign. Merge into traffic and stay in the right lane. Travel approximately 0.5 miles and turn right at the sign for the Best Western Hotel. Trade Center will be ahead on the left. Hotel is further ahead at the end of the road.

**From the South:** Follow the ramp to the stop sign. Merge into traffic and cross over Interstate 495, staying in the right lane. Follow directions above.
