All dogs entered in the Bred-By class must be individually registered with the AKC The Person handling the dog must be breeder of record of the dog and an owner of record of the dog.

To exhibit in this class, family members must be a breeder and owner of record.

Non-Regular Classes - Involving Multiple Dog Entries

As the judge's decisions in the Non-Regular Classes involving Multiple Entries are based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the
